## Melodie Aduja

#### Will Caron



Aloha fellow O'ahu County Democrats! My name is Will Caron and I was born in Honolulu in 1989. I was raised for a short while in Liliha and then mostly in Temple Valley at the border between Kahalu'u and Kāne ohe. I am a proud graduate of the University of Hawai'i at Mānoa and now a resident of beautiful Pālolo Valley.

A lot has happened in Hawai'i over the past few decades. Some are good things—like the growth of a strong Aloha 'Āina movement that has changed the conversation at the capitol around resource stewardship, indigenous rights, environmental protection, and racial justice, or the advancement of social equality marked by the establishment of Marriage Equality.

But when we look back over the past 30–40 years, we can see how an

already hard-to-afford life in Hawai'i has fallen even further out of reach for many residents. I've watched my parents, my sister, and many of my friends make the painful decision to move away because Hawai'i is simply too expensive. It's too expensive to start a family; and it's too expensive to retire. More than half of Hawai i households now spend at least 30 percent of their income on sky-high housing costs, and more almost 300,000 workers in Hawai'i work jobs that pay less than a living wage. And our dependence on tourism and the military as economic supports has caused terrible harm to our environment and people.

My desire to make a difference in solving these problems here in Hawai'i is what led me to switch careers from journalist to advocate and organizer. It's also what led me to join the Democratic Party—because this is the party of change and transformation in Hawai'i. We are the party that embraced the immigrant and labor movements in the mid 20th century to transform the exploitative plantation economy.

But while that represented real progress, There is still so much that must be done before we realize a truly just, equitable and sustainable society here in Hawai'i. I want to work within the Democratic Party to help make that happen.

As a Democrat, I've served as the District 20 chairperson since 2018, and have attended just about every O'ahu County Committee meeting during that time. I've attended every county and state convention since 2017 and have volunteered for and served on a convention committee each time. That inludes the 2019 O'ahu County Convention, when I chaired the Resolutions Committee and guided the passage of 24 different resolutions.

I've worked well with three different state party chairs and two county chairs, and I've always done everything I can to ensure my district is fully represented at all conventions and meetings.
