**FEBRUARY 6:** Registration materials mailed to convention delegates

**FEBRUARY 12, 11:59 PM:** Deadline to sign up for convention committees (Platform, Rules Resolutions)

**FEBRUARY 19, 10 AM:** Special meeting of the OCC to confirm committee appointments

### **LAST DAY FOR EARLY BIRD REGISTRATION**

**FEBRUARY 21, 11:59 PM:** Last day to submit proposed resolutions, platform planks, and amendments to DPH Constitution & Bylaws.

**FEBRUARY 23-MARCH 4:** Platform, Rules, Resolutions Committee Meetings

### **MARCH 5: LAST DAY FOR REGULAR REGISTRATION**

**MARCH 9:** Last day for nominations for OCC Representatives to the SCC.  
Postmarked by March 7 or received online by March 9, 11:59 PM

**MARCH 9, 11:59 PM:** Last day for delegates not attending the convention to appoint their own alternates.

If an elected delegate cannot attend, they may appoint their own alternate provided that they notify the District Chairperson in writing at least ten (10) days prior to the convening of the convention and;

- i. The appointed alternate reside in the district; and
- ii. A best effort is made to ensure the selected alternate is of the same gender as the elected delegate; and
- iii. An alternate shall act for no more than one (1) delegate at a time; and
- iv. If the elected delegate does not appoint an alternate ten (10) days prior to the convening of the Convention, the District Chairperson shall be empowered to appoint the alternate, provided that a best effort is made to appoint an alternate of the same gender as the elected delegate.

**MARCH 9, 11:59 PM:** Last day for District Council to fill At-Large delegate positions. If, following the Precinct Elections, there remain vacant At Large delegate positions, the District Council shall be empowered to fill the remaining positions, up until ten (10) days prior to the convention, after that the District Chairperson shall be empowered, provided that:

- i. Best attempts are made to ensure gender equity is maintained; and
- ii. District Council meetings to fill vacancies may be conducted by videoconference, phone or email;
- iii. Appointments shall be in writing.

**MARCH 10:** Secretary sends email to all delegates re: nominations and recommendations from committees as posted on the county website. Delegates may submit separation and amendments forms.

**MARCH 12:** Last day for postmarked convention registrations.

**MARCH 14, 11:59 PM:** Last day to submit additional delegate names by District Chairs.

**MARCH 16, 11:59 PM:** LAST DAY TO REGISTER FOR THE CONVENTION

**MARCH 18, 8 AM:** Last date and time to accept separations and amendments from the committee recommendations.

**MARCH 19, 8 AM-3 PM:** THE O'AHU COUNTY CONVENTION
