- If you expect to move an amendment to the separated bylaw amendment, platform plank, or resolutions, you **MUST** also complete the Amendment Section of this Form. If you wish, you may email your answers to these questions and an amendment to convention@oahudemocrats.org.
- The requester will be recognized first by the Chairperson and expected to speak against the above named proposal or resolution and/or to move an amendment to the above named rule, plank, or resolution.
- Do not use this submission form unless you are requesting to speak against and/or amend the rule, plank or resolution you name in this form.

(7.1) A “proxy” shall mean the authority to vote on items listed on the applicable agenda and shall not extend to the discussion of or vote on items not listed on the agenda. All proxies must be assigned in writing, filed with the Secretary of the OCC and the OCC Chairperson, and shall only be valid for the meeting designated. Such members who assign their proxy shall still be considered absent even though a proxy has been assigned unless excused by the OCC Chairperson. An unexcused absence, meaning a member was unable to assign a proxy, can be appealed to the OCC Executive Committee, but only at the immediately following OCC Executive Committee meeting.

(7.2) A District Chairperson may ~~[give]~~assign their proxy to another officer member of their District Council in accordance with Article III -"District Council" of the Bylaws of the Democratic Party of Hawai‘i. ~~[All proxies must be in writing and shall be filed with the Secretary of the OCC and the OCC Chairperson. In the absence of the District Chairperson, the First Vice Chairperson shall have the right to vote and represent the District without further designation or proxy. The District Chairperson shall still be considered absent even though a proxy has been given unless excused by the OCC Chairperson.]~~

(7.[2]3) A Regional Chairperson may ~~[give]~~assign their proxy to a District Council officer member in their region. ~~[All proxies must be in writing and shall be filed with the Secretary of the OCC and the OCC Chairperson. The Regional Chairperson shall still be considered absent even though a proxy has been given unless excused by the OCC Chairperson. An unexcused absence can be appealed to the OCC Executive Committee, but only at the next OCC Executive Committee meeting.]~~

(7.[3]4) The following members of the Executive Committee may ~~[give]~~assign their proxy to other Executive Committee members: OCC Chairperson, Vice Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, and the Oahu County State Central Committee Representatives. ~~[All proxies must be in writing and filed with the Secretary of the OCC and the OCC Chairperson. Such members shall still be considered absent even though a proxy has been given unless excused by the OCC Chairperson.]~~
