Delegates at the 2022 Hawai`i Democratic Party (DPH) Convention voted to change the DPH Constitution & Bylaws to eliminate Precinct Clubs and establish a new organization of the District Council at the Biennial Election.

THE OLD BIENNIAL ELECTION

- **1. Precinct Clubs meet to elect officers**
- 2. Precinct Clubs meet to elect State Convention delegates.
- 3. 3 Representatives from the Precinct Clubs constitute the **District Council.** They elect the District Chair and District **Officers.**

4. Members of the District Council are automatic delegates to the County Convention. All members of the District elect the remaining at-large delegates to total 25 per district, and

THE ELECTION OF THE NEW DISTRICT COUNCIL

to elect members of the District Council (DC) in this order:

- 1. Officers of the District Council in this order: Chairperson, Vice Chairperson, Secretary, Treasurer.
- members who reside in Precincts not represented on the DC will have the opportunity to be elected to one position on the DC, provided those members are present and willing to run. positions on the DC up to fifteen total members of the DC.
- 2. Five additional at-large Council members (called "Directors"). 3. After the election of the first nine members of the DC, District 4. The election resumes by filling the remaining Director

At the Biennial Election Meeting, all members of the District vote

THE PROPOSED AMENDMENTS TO THE O`AHU COUNTY DEMOCRATS BYLAWS

To be voted on at the OCC meeting on August 6, 2022

In response to the amendments to the DPH **Constitution & Bylaws, substantial changes were** made to two O`ahu County Bylaws: 4.1 and 12.4

Bylaw 4.1:

Informs the reader about the composition of the new District Council by quoting the relevant portions of the DPH Constitution, Article III.

Bylaw 12.4:

- **District membership at the Biennial Election**

 As before the number of elected delegates per District remains at 25. Members elected to the District Council automatically become delegates. The remaining delegates will be elected on an at-large basis by the

- The remaining delegates will be elected on an at-large basis by the District membership at the Biennial Election meeting. Alternate delegates may also be elected. (The Bylaws amendments codify the practice of electing alternates. The current Bylaws allow the withdrawing delegate to select their own replacement.)
- If a delegate determines in advance of the Convention they are unable to serve, the District Chairperson will select their replacement from the list of alternate delegates. If there is no alternate list, the District Chairperson will fill vacancies on a first-come, first-served basis, but will try to find a replacement of the same gender.

- The 2 elections to be held: **1. District Council**
- 2. Delegates to the County Convention District Chairs or meeting conveners will be provided with packets with scripts, lists, and reporting forms for the meetings.
